**Passport Conditions:**

- ❖ **Fee Structure:** The El Reno Recreational Authority, in its sole discretion, shall determine the amount of annual fees for the Golf Passport. Annual fees are non-refundable. In the event of illness or injury preventing a Passport Holder from playing a substantial amount of the term, the General Manager, in his/her sole discretion, may issue a credit to be applied to the following year's fees. Any Passports issued after July 1<sup>st</sup> will be pro-rated accordingly.
- ❖ **Personal Property:** Crimson Creek shall not be responsible for any loss or damage to any personal property left or stored on the Golf Course premises.
- ❖ **Dress Code:** Proper and customary golf apparel must be worn when using the course or practice facility. Passport holder agrees to abide by the Dress Code posted in the Pro Shop.
- ❖ **Course Rules:** Course rules posted throughout the facilities and course are designed to make the course operate more efficiently with each round of golf being pleasant and enjoyable. All golfers at all times must comply with these rules. **Failure to follow these rules may result in Suspension or Expulsion of Passport.**
- ❖ **Outside Food and Beverage:** All outside food and beverages are prohibited at Crimson Creek Golf Course
- ❖ **Carts:** All carts, including private carts, must adhere to the 90 degree rules at all times unless otherwise specified.
- ❖ **Managements Rights:** Management has the right to suspend or expel the privileges of any Passport Holder from Crimson Creek Golf Course for:
  - A. Violation of any terms of this agreement
  - B. Conduct prejudicial or detrimental to the interests of the City of El Reno and/or Crimson Creek Golf Course
  - C. For reasons of Management's sole discretion

**Additional Terms and Conditions:**

- ▶ **Ownership:** Passes are non-transferable and non-refundable.
- ▶ **Registering:** All Passport holders must check-in with the Pro-shop staff **PRIOR** to playing. Passports do not entitle pass holders unauthorized or unlimited access without the knowledge and consent of the Pro-shop staff. Failure to comply may result in suspension or termination of all Golf privileges.
- ▶ **Golf Course Privileges:** Access to the golf course is subject to availability. Certain private events may dictate that the golf course, practice areas or other areas of Crimson Creek be closed. Passport holder understands and agrees that nothing in this Agreement shall entitle pass holder to any of the facilities on any particular day nor to any discount or refund on account of any limited access. Passport holder further understands that Crimson Creek Golf Course as necessary may limit access to the course, practice facility and other privileges and benefits.
- ▶ **Golf Carts:** Use of golf carts are restricted to Crimson Creek customers. Golf carts **MUST** be signed out prior to each use. **Only licensed drivers over the age of 18 may operate the cars.** You must adhere to the rules and regulations, as set forth and/or all posted instructions.
- ▶ **Code of Conduct:** *All golfers agree to abide by the rules and regulations of Crimson Creek Golf Course. The management, for violation of any rule or regulation of Crimson Creek or for conduct, which in the opinion of the management is detrimental to the welfare, safety and character of Crimson Creek or the City of El Reno, may expel any player.*
- ▶ **Damage or Injury to Person or Property:** Passport holder agrees to pay for any damages to the facilities or grounds or for injuries to any person, caused by pass holder. Passport holder also agrees to hold Crimson Creek, the City of El Reno and its employees, agents, and owners, harmless and to defend them against any and all claims, damages, and suits, for damages or injuries of any nature, whether to pass holder or to others, that may arise from or be related to members use of the golf course, its facilities or equipment.
- ▶ **Property and Equipment:** Crimson Creek property includes equipment provided for our guests to use. These items may not be taken out of their designated areas. Removal of these items from Crimson Creek property will be deemed as theft and violators may be charged.
- ▶ **Cancellation:** A breach of any of the terms and conditions of this contract will result in the cancellation of Passport holder’s rights and privileges without any reimbursement of any kind. Should Passport holder wish to cancel this agreement prior to its stated expiration for any reason whatsoever, there will be no refund, partial or otherwise, on the fees paid by Passport holder.
- ▶ **Miscellaneous:** In case any one or more of the provisions contained in this Agreement shall for any reason be held invalid, illegal, or unenforceable in any respect, such as invalidity, illegality, or unenforceability shall not affect any other provision, and this Agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained herein. This Agreement embodies the entire agreement and understanding of the parties relating to the subject matter hereof, is non-assignable, may not be amended except in writing signed by both parties, and supersedes any prior representations, agreements, and understandings, oral or written, if any, relating to such subject matter.

Passport Period: **July 1, 2023 thru June 30, 2024.** This contract is non-renewable
